The Reporting Person has an interest in the unitized fund, which holds shares of Series A Liberty Capital Common Stock, Series A Liberty Interactive Common Stock, Series A Liberty Starz Common Stock and short-term investments.

- (2) The total shares owned was decreased by one share due to the Reporting Person's receipt of one less shares to which he was entitled in the redemption described in the Reporting Person's Form 4 filed on 11/23/09.

- (3) The stock option vests as to one-half of the total shares on the fourth anniversary of the grant date and the balance will vest on the fifth anniversary of that date.
