- (4) The option vests as to 82,236.875 shares semi-annually over four years from the grant date of March 1, 2010; partial shares vest when remainder includes full share.
- (5) The option vests as to 1,900,000 shares on December 15, 2014 and 1,900,000 shares on December 15, 2015.
